

CHRIS ADELSBACH Managing Director, TechStars & UKBAA Angel of the Year 2018-19

Chris is a London-based entrepreneur, FinTech investor, advisor, and mentor. He is a Managing Director at Techstars, the worldwide network that helps entrepreneurs succeed. He is an angel investor in over 50 companies including Atom Bank, Smart Pension, Atlas Money, Post Quantum, Everledger, Cuvva, Simudyne, Railsbank and Shieldpay to name a few. Fintech Global recently named Chris as the most active Fintech angel globally over the past three years. He has spoken at numerous trade missions and is frequently asked to advise international banks who want to launch open-innovation platforms and governments who want to support startup ecosystems. He mentors FinTech founders in London, New York, Tel Aviv, Dubai and Cape Town.



DR ADAM BEAUMONT Founder & CEO, AQL & Founder, NorthInvest

Adam is an active angel investor with a portfolio spanning healthcare, education, collaboration tools, and technology for social change. He also founded the not-for-profit investment platform NorthInvest which drives co-investment in startups across the North of the UK. As an ex-lecturer at the University of Leeds and a communications specialist within the MoD, Adam is a consistent innovator and technologist with a strong cyber security background. In 1998, he created telecommunications platform company, aql which today hosts many tens of millions of phone numbers and providing messaging and communication services to leading banks, retail, logistics, healthcare and education. He's created enabling services which are used by some of San Francisco's biggest tech success stories.



BRUCE COLLEY Access to Finance Manager, Innovate UK

As the Access to Finance manager at Innovate UK my role is to help the SMEs and early-stage businesses we support to connect with sources of private sector debt and equity finance (and other forms of business support such as coaching and mentoring). This in turn enabling them to commercialise their innovations and grow their businesses. Previous experience with over 6 years as Investment Director of a business angel network and also directly brokering angel / VC deals provides me with a clear understanding of what makes a business attractive to investors and VCs.



JOYEETA DAS CEO & Founder, Gyana

Joyeeta Das is an entrepreneur that built a career in the technology sector. She founded and exited two successful startups, one in tech sector and one in non-profit. Her latest venture – Gyana – has raised \$3.5m in funding. She holds a degree in Electronic Engineering, a degree in Physics and an MBA from Oxford University where she was awarded the Said Scholarship and also received a Fellowship for the Entrepreneurship Centre. Joyeeta is in "MIT 35 under 35" shortlist, a Tedx speaker, an ambassador for Innovate UK's "Women In Innovation", she volunteers with numerous charitable organisations and has been selected to be a diplomatic representative at UK- Brazil/ Canada/USA trade delegations. She was awarded "Top 100 techie in UK" by MSDUK 2017, "Top 100 Asian TechStars in UK Tech" 2017 and "Top 10 Women in IT" 2018.



THOMAS DAVIES Chief Investment Officer, Seedrs

Tom is a qualified lawyer in England and New York and began his career with Freshfields Bruckhaus Deringer LLP in London, Hong Kong and New York. Irene is the CEO and a board director of the ScaleUp Institute. A former senior banker at Standard Chartered Bank where she held both European and global managing director roles, she set up, ran and scaled several of the bank's key client and product businesses across its corporate and institutional bank and led several global M&A activities. Before joining the ScaleUp Institute she was Managing Director at the British Bankers Association. She led a host of strategic work across the industry from the regulatory and business perspectives, including leading the Business Finance Taskforce set up by the CEOs of the UK banks which resulted in the creation of the BGF, the Enterprise Research Centre, the SME Finance Monitor, and Mentorsme as well as being responsible for new export and business policy initiatives including the Small Business Act, expanded UKEF products and Open Banking which Irene advised Government and industry upon.



IMRAN GULAMHUSEINWALA OBE Implementation Trustee, Open Banking Implementation Entity

Mr. Gulamhuseinwala was appointed as Trustee for the Open Banking Implementation Entity (OBIE) on 13 April 2017. In his role as Trustee, he has oversight and responsibility for Open Banking's development and delivery of the common technical standards underpinning the Competition and Market Authority's (CMA) open banking initiative. He is seconded to Open Banking from Ernst & Young LLP (EY) where he is a London-based partner in its financial services practice. He is also EY's Global Head of FinTech. At EY, he has worked closely with government, regulators and industry bodies to drive the FinTech agenda, leading studies for both UK Trade & Investment and HM Treasury to measure the size and growth of the FinTech sector in the UK and develop a strategy for future growth. He was awarded an OBE in the New Year's Honours list for his contribution to the financial services sector.



RICHARD HADDEN Partner, Breed Reply

Richard is a partner at Breed Reply, the IoT investment and incubation arm of Reply SpA, where he is the Director of Investment. He has spent nine years in operating roles, as business development director of nGame (subsequently Hands-on Mobile) and CEO of Cytox, alternated with nine years of venture capital investment management, most recently at Finance Wales.



ANDREW JENKINS Founder, Conviction Investment Partners

Andrew is the founder and CEO of Conviction Investment Partners (CIP), a syndicate of international HNWIs and family offices that invest opportunistically in a variety of fast-growing tech companies. He has invested in disruptive technologies for over 15 years thereby developing an impressive investor following. Andrew was the lead financier and investor in Mimecast during its first 5 years; the business went on to list on NASDAQ with a market cap of circa \$2bn. More recently, Andrew and his syndicate of angels participated in an investment in iZettle which yielded strong returns upon its sale to PayPal earlier this year. Prior to fully committing himself to venture capital, Andrew had successful career in trading and investment management. He was the Head of Private Clients at GAM for 7 years.



MILES KIRBY Managing Director, AV8 Ventures

Miles Kirby is Managing Director AV8 Ventures. AV8 is a €150m fund investing at Seed and Series A stages in Next Generation Mobility, Big Data and AI, Digital Health and Cybersecurity in Europe and the US. Prior to AV8 Ventures Miles was Managing Director of Qualcomm Ventures, leading Qualcomm's investments in Europe. At Qualcomm Ventures Miles lead investments such as Iridigm, A123, Fon, Formula E and Voluntis. While at Qualcomm Miles formed and ran an internal incubator and developed Qualcomm's effort in Augmented Reality, Wireless Charging and Machine learning and holds 34 patents. Miles holds an BA in Electronics and Communication Engineering from Bristol University and an MBA from University of California, Irvine.



TIM LEVETT Chairman, NVM Private Equity

Tim is Chairman of NVM Private Equity. He has been key to building up the company's broad range of investee companies. Tim is responsible for investor relations and continues to represent NVM on the board of Clarilis, Newcells Biotech, Channel Mum, Crantock Bakery, Gentronix and Intuitive. He has also worked with Alaric Systems, Control Risks Group, Liquidlogic, TFB, Keith Prowse and DxS, to name but a few. Tim is also a non-executive director of Northern Venture Trust PLC and Northern 3 VCT PLC. He is also twice winner of the prestigious BVCA Deal of the Year award. Tim is also Vice Chair of the recently formed Venture Capital Trust Association (VCTA) which represents ten of the largest venture capital trust managers in the UK.

Catherine joined the British Business Bank Group in 2016 when she was appointed CEO of British Business Investments, the Bank's commercial arm engaged primarily in direct lending strategies. In October 2018 Catherine took on the additional role as CEO of British Patient Capital, a recently established commercial subsidiary with a mandate to make long term equity investments in high growth businesses in the UK. She was previously Head of Private Equity at Cardano Risk Management where she was responsible for managing a global portfolio of private capital investments with in excess of £1 billion of committed capital. Prior to this she was Managing Director with secondaries specialist, Fondinvest Capital, in Paris. Catherine was one of the Founding Partners of Nordic fund-of-funds manager, Proventure and subsequently launched her own consulting business advising institutional investors in the US and Asia on their European private capital strategies.



ELINA NAYDENOVA CEO & Founder, Feebris

Dr Elina Naydenova is a biomedical engineer and data scientist, developing disruptive solutions to large global health challenges. After years of academic research at the University of Oxford and development of intelligent algorithms for remote diagnosis, Elina founded Feebris to power precision medicine beyond the clinic. Feebris is developing an Al-engine for early detection and monitoring of respiratory conditions away from the hospital. Feebris' advanced machine learning algorithms process signals of off-the-shelf sensors to derive actionable clinical insights and prevent avoidable complications. She is a Fellow to the Young Transatlantic Innovation Leaders Initiative, recipient of the 2017 Children's Prize, and holds degrees from University of Oxford (PhD in Machine Learning for Health Innovation, MSc Biomedical Engineering) and Warwick University (BSc Mathematics & Physics).



DAVID OVENS Chief Operating Officer, Archangels

David is an experienced corporate financier, having worked for Samuel Montagu & Company Limited, Noble Grossart Limited and Noble & Company Limited, before setting up Invercap, a corporate advisory boutique based in Edinburgh. In recent years, he has advised, invested in and been involved operationally with a number of early stage companies. David joined Archangels in 2014. He has responsibility for operational aspects of the Archangels' business and also has direct responsibility for a number of the portfolio companies.

HENRY WHORWOOD Senior Consultancy Associate, Beauhurst




